ORDINANCE 19-05-19

AN ORDINANCE AMENDING THE SPEED LIMITS PRESCRIBED IN SECTION 7-3-13 OF THE MUNICIPAL CODE OF ANTIOCH RELATING TO SAVAGE ROAD

WHEREAS, the provision of an adequate and safe street system is a core function of municipal government, and

WHEREAS, the setting of speed limits is necessary for allowing safe movement of vehicles, pedestrians and other traffic to, from and through all parts of the Village, and

WHEREAS, the corporate authorities have tasked the Traffic Calming Committee with reviewing the speed limits on Savage Road following complaints from a number of residents of their perceptions of excessive speed along portions of that road, and the Committee has reported that the complaints are well-founded, and

WHEREAS, the corporate authorities accordingly find that it is necessary to adopt revised speed limits on Savage Road so as to provide increased safety within the area it serves, and

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The table of speed limits for Savage Road set forth in Section 7-3-13 of the Antioch Municipal Code is hereby amended and it shall hereafter provide as follows:

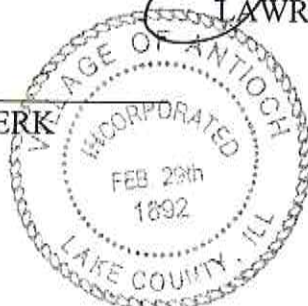
Savage Road	Illinois Highway 173 to White Road	35 mph
Savage Road	White Road to Miller Road	30 mph

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
