## **ORDINANCE 19-05-20**

### **AN ORDINANCE REPEALING AND REPLACING CHAPTER 7-2 OF THE MUNICIPAL CODE OF ANTIOCH RELATED TO PARKING**

**WHEREAS**, the Village has long provided for vehicle parking on public ways and on publicly owned property within the downtown business district, and

**WHEREAS**, the principal provisions of the Antioch Municipal Code dealing with such parking is set forth in Chapter 7-2 of the Code, which is entitled "Parking Meters", and

**WHEREAS**, the Village discontinued using parking meters at all of its downtown locations a number of years ago other than the daily cash box at the Metra Station, and

**WHEREAS**, the Village Board finds that it is necessary and appropriate to repeal the obsolete provisions of Chapter 7-2 and provide a modernized version of the parking regulations in order to foster an improved accessibility to parking areas and ensure that residents, business owners and trade customers have ready parking available to meet their needs on a regular basis,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** Chapter 7-2 of the Antioch Municipal Code entitled "Parking Meters" is hereby repealed and replaced with the following Chapter:

#### **CHAPTER 7-2 DOWNTOWN PARKING**

**7-2-1 Coverage Area:** The provisions of this Chapter will apply to the "Downtown Parking Area" which is bounded by the following streets:

- Skidmore Drive on the East;
- Park Avenue on the South (including an imaginary extension thereof to Victoria Street;
- Spafford Street on the West (including an imaginary extension thereof to Orchard Street;
- Orchard Street on the North.

**7-2-2 General Regulation and Prohibition:** Vehicles shall be permitted to park in the Downtown Parking Area only in painted, designated parking spaces, and only during the durations allowed for such parking in the regulations set forth in this Chapter. It shall be unlawful to park vehicles in any manner which is not in conformity with the regulations so described. Fines for violations of these regulations are set forth in 1-3-1A of this Code.

7-2-3 Parking Area Designation: The Superintendent of Public Works shall cause parking spaces to be painted within the areas designated in this Chapter, and in particular shall provide for handicapped-accessible parking spaces in conformity with 625 ILCS 5/11-1301.1 et. seq.

7-2-4 Parking Durations: On the following streets and publicly owned parking lots, vehicles may be parked for periods not to exceed the times listed below:

<b>Parking area or street</b>	<b>Duration</b>
Lot west of Skidmore, between Orchard and bandshell	4 hours
Lot west of Skidmore, south of bandshell, north bank of spaces	8 hours
Lot west of Skidmore, south of bandshell, middle two banks	4 hours
Lot west of Skidmore, south of bandshell, southernmost bank	24 hours, tenants only
Main Street, east side, between Lake and Orchard and west side, between Park and Orchard	6 am to 5 pm - 2 hours 5 pm to 3am - no limit 3 am to 6 am - no parking
Lake Street, north side between Main and Toft (except as noted below)	6 am to 5 pm - 2 hours 5 pm to 3am - no limit 3 am to 6 am - no parking
Lake Street, north side, in front of 383 Lake Street	15 minutes
Lake Street, south side, between Main and Spafford	6 am to 5 pm - 2 hours 5 pm to 3am - no limit 3 am to 6 am - no parking
Toft Street, on-street parking	6 am to 5 pm - 2 hours 5 pm to 3am - no limit 3 am to 6 am - no parking
Lot east of Toft, except as noted below	6 am to 5 pm - 2 hours 5 pm to 3am - no limit 3 am to 6 am - no parking
Lot east of Toft, western two banks	6 am to 5 pm - Village employee parking only 5 pm to 3am - no limit 3 am to 6 am - no parking
Orchard, between Toft and Main, north side	30 minutes
Lot south of Orchard, northeastern bank	24 hours, tenants only
Lot south of Orchard, northwestern bank	6 hours
Lot south of Orchard, two northern long banks	6 hours
Lot south of Orchard, two southern long banks, east third	8 hours
Lot south of Orchard, two southern long banks, west 2/3	Permit only
Lot south of Orchard, southwest bank	Permit only
Lot south of Orchard, southeast bank	6 hours



**SECTION TWO:** For the convenience of the public and law enforcement, the Administrator may, but is not required to, keep a graphical map depicting the downtown parking area and may make it available to the public online through the Village's website. However, in the event of a conflict between the provisions of Section One of this Ordinance and the map, the provisions of Section One shall govern.

**SECTION THREE:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
