**ORDINANCE 19-07-28**

**AN ORDINANCE REPEALING REPEALING ARTICLE B OF TITLE 1, CHAPTER 6 OF THE VILLAGE CODE RELATED TO ADMINISTRATION AND DEPARTMENTS**

**WHEREAS**, on November 8, 2016, a referendum question was duly placed on the ballot asking the voters of the Village of Antioch whether or not to merge the Village Fire Department into the First Fire District, and

**WHEREAS**, as a result of the referendum passing, the Village Board approved Resolution No. 16-80 “Acknowledging the vote of the people and directing the Administrator to work with the Antioch First Fire District to wind down the affairs of the Village Fire Department, and

**WHEREAS**, the transition has now been completed and the First Fire District has been operating as its own taxing body, and

**WHEREAS**, Village Code Section 1-6B, which creates an executive department of the Village known as the Fire Department, is no longer needed,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** Title 1, Chapter 6, of the Antioch Municipal Code is hereby amended by the repeal of Article B, titled “Fire Department”.

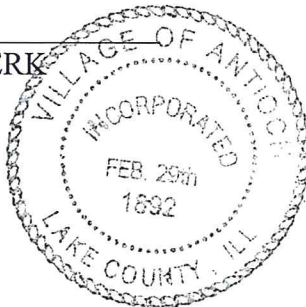
**SECTION TWO:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
