ORDINANCE 19-08-31

**AN ORDINANCE ADDING NO PARKING ZONES ON DROM COURT,
IDA STREET, BISHOP STREET, AND CHESTNUT STREET**

WHEREAS, the Village has long provided for vehicle parking on public ways, and

WHEREAS, from time to time Village Staff and its Traffic Safety Committee review parking regulations on Village Streets to ensure that public safety is well-balanced with the need for parking of vehicles along those public ways, and

WHEREAS, the Traffic Safety Committee has recommended that parking be restricted along several roads near the high school and along a mixed use roadway designated as Drom Court in order to provide increased public safety and convenience to residents and accessibility to first responders, and

WHEREAS, the Village Board finds that the recommendations of the Traffic Safety Committee are appropriate and will provide a better balance of public safety and convenience to the citizens, taxpayers and visitors to Antioch,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The chart of Prohibited Parking set forth in Section 7-3-1 B of the Antioch Municipal Code is hereby amended by adding the following line items to the chart:

| Street | Side | Between |
|-----------------|-------------|----------------|
| Drom Court | West | Entire length |
| Ida Street | South | Entire length |
| Bishop Street | Both | Entire length |
| Chestnut Street | Both | Entire length |

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.




