#### **ORDINANCE NO. 20-11-37**

### AN ORDINANCE APPROVING THE FINAL PLAT FOR THE SITKO RESUBDIVISION

WHEREAS, the applicant has submitted a proposed Final Plat prepared by Chamberlin/Masse dated September 1, 2020, and

WHEREAS, the applicant is seeking to re-subdivide and combine five essentially non-conforming single-family lots into three single family lots that would meet the minimum lot sizes within the R-2 and R-3 zoning districts, and

WHEREAS, the proposed Final Plat went before the Planning and Zoning Commission on October 8<sup>th</sup>, 2020 and the Planning and Zoning Commission recommended approval of the Final Plat by a vote of 4-0, and

WHEREAS, that a stipulation was added to the Final Plat approval that the applicant would be required to construct a sidewalk along Naber Avenue concurrent with the sale or development of each lot.

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** That the Village President and Board of Trustees of the Village of Antioch hereby find that the Sitko Final Plat for re-subdivision complies with Section 11-2-4 of the Antioch Municipal Code as it relates to approval of a Final Plan.

**SECTION TWO:** The Village will proceed with recording the Final Plat mylar subject to the applicant complying with the requirements of a Final Plat submittal as outlined in Section 11-2-4 of the Antioch Municipal Code.

**SECTION THREE:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
