AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO SELL, SALVAGE OR OTHERWISE DISPOSE OF EQUIPMENT

WHEREAS, the Village Administrator would like to sell, salvage or dispose of vehicles, equipment or materials considered to be surplus property of the Village, and
