**Ordinance No. 21-07-18**

***AN ORDINANCE GRANTING A TATTOO LICENSE TO SALT SALON AND SPA LLC FOR SALT SALON AND SPA TO BE LOCATED AT 744 MAIN STREET #101***

**WHEREAS**, the Village of Antioch (“Village”) is an Illinois non-home rule municipality organized and operating under the Illinois Municipal Code (65 ILCS 5/1, et seq.) (the “Code”); and

**WHEREAS**, the Village President (the “President”) and the Village Board of Trustees (the “Village Board”, and together with the President, the “Corporate Authorities”) are committed to the health, safety, and welfare of its residents; and

**WHEREAS**, the Village has received an application for a tattoo license (the “License”) from Salt Salon and Spa LLC (the “Applicant”) for the Salt and Salon Spa (the “Spa”) to be located at 744 Main Street #101; and

**WHEREAS**, the Applicant has indicated that the only “tattooing” that would be performed at the Spa is a technique called “microblading”; and

**WHEREAS**, microblading is a semipermanent technique for enhancing the appearance of the eyebrows, in which pigment is scratched into the skin in fine, short strokes resembling hair, using a hand tool with a blade formed of tiny needles; and

**WHEREAS**, pursuant to Section 4-7-8 of the Municipal Code of Antioch, the structure housing a tattoo studio must be greater than four hundred eighty feet (480’) from any part of the property on which any church, public school, playground or athletic field is located (the “Distance Requirement”); and

**WHEREAS**, according to the Village’s geographic information systems (“GIS”) coordinator, the proposed structure housing the Spa would be located approximately four hundred seventy feet (470’) feet from a little league field; and

**WHEREAS**, the Corporate Authorities have determined that providing microblading at the Spa is not tantamount to services performed at a traditional tattoo parlor; and

**WHEREAS**, based on the foregoing, the Corporate Authorities have determined that it is necessary, advisable, and in the best interests of the Village, and its residents, to waive the Distance Requirement and grant the License on the condition that microblading is the only form of tattooing completed at the Spa;

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Antioch, Lake County, Illinois, as follows:

**SECTION 1:** The Corporate Authorities hereby grant the License subject to the condition that the only form of tattooing to be completed at the Spa is microblading.

**SECTION 2:** All ordinances, resolutions and orders or parts of ordinances, resolutions and orders in conflict with this Ordinance are superseded to the extent of such conflict.

SECTION 3: The Village Clerk shall cause this Ordinance to be published in pamphlet form.

SECTION 4: This Ordinance shall be in full force and effect after passage and publication as provided by law.
