AN ORDINANCE GRANTING A TATTOO LICENSE TO MOLLY DEWAR FOR BLACK CHAPEL TATTOO TO BE LOCATED AT 430 LAKE STREET

WHEREAS, the Village of Antioch ("Village") is an Illinois non-home rule municipality organized and operating under the Illinois Municipal Code (65 ILCS 5/1, et seq.) (the "Code"); and

WHEREAS, the Village President (the "President") and the Village Board of Trustees (the "Village Board", and together with the President, the "Corporate Authorities") are committed to the health, safety, and welfare of its residents; and

WHEREAS, the Village has received an application for a tattoo license (the "License") from Molly Dewar (the "Applicant") for the operation of Black Chapel Tattoo to be located at 430 Lake Street; and

WHEREAS, the Village Board has considered the application and determined that the License is appropriate for the suggested location and type of business, and the Applicant is an appropriate designated licensee based on the application for the License;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Antioch, Lake County, Illinois, as follows:

<u>SECTION 1</u>: The Corporate Authorities hereby grant the License.

<u>SECTION 2</u>: All ordinances, resolutions and orders or parts of ordinances, resolutions and orders in conflict with this Ordinance are superseded to the extent of such conflict.

SECTION 3: The Village Clerk shall cause this Ordinance to be published in pamphlet form.

SECTION 4: This Ordinance shall be in full force and effect after passage and publication as provided by law.
