# AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO SELL, SALVAGE OR OTHERWISE DISPOSE OF EQUIPMENT

WHEREAS, the Village of Antioch ("Village") is a municipality located in Lake County, Illinois, and

WHEREAS, the Village Administrator would like to sell, salvage or dispose of vehicles, equipment or materials considered to be surplus property of the Village, and

**WHEREAS**, pursuant to Chapter 65, Act 5 Section 11-76-4 of the Illinois Compiled Statutes, the Mayor and Board of Trustees of the Village of Antioch find the property described in Exhibit "A" now owned by said jurisdiction is no longer useful to said jurisdiction and would be best served by the sale or disposal of the property, and

WHEREAS, the equipment to be sold or disposed of are beyond economic repair and every effort will be made to sell such equipment,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** Attached as "Exhibit A" is a list of items to be sold or disposed of.

**SECTION TWO:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
