Ordinance No. 22-03-17

AN ORDINANCE AMENDING SECTION 4-2B-10 OF THE ANTIOCH VILLAGE CODE REMOVING THE PROHIBITION AGAINST VIDEO GAMING AT THE PREMISES OF A CLASS "C" LIQUOR LICENSE HOLDER DURING EXPANDED SAMPLING EVENTS

WHEREAS, the Village of Antioch ("Village") is an Illinois non-home rule municipality organized and operating under the Illinois Municipal Code (65 ILCS 5/1-1-1, et seq.); and

WHEREAS, the Village President (the "President") and the Village Board of Trustees (the "Village Board" and together with the President, the "Corporate Authorities") are committed to promoting, protecting, and preserving the health, safety, and welfare of its residents and businesses; and

WHEREAS, Section 4-2B-10 of the Antioch Village Code (the "Village Code") sets forth the classes of liquor licenses allowed in the Village; and

WHEREAS, Subsection 4-2B-10(C) of the Village Code governs the "Class C: Retail Package Sales" liquor license (the "Class C License"), and regulates all activities involving extended sampling, sampling and tasting for a Class C License; and

WHEREAS, the Corporate Authorities have determined that the Village's prohibition against video gaming during extended sampling events or activities held by holders of the Class C License is no longer necessary; and

WHEREAS, the Corporate Authorities desire to amend the expanded sampling subsection to allow the holders of the Class C License to offer video gaming on their premises during these events or activities; and

WHEREAS, based on the foregoing, the Corporate Authorities have determined that it is necessary, advisable, and in the best interests of the Village, and its residents, to amend Section 4-2B-10 of the Village Code;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Antioch, Lake County, Illinois, as follows:

<u>SECTION 1</u>: The Village Code is hereby amended, notwithstanding any provision, ordinance, resolution, or Village Code section to the contrary, by amending Title 4, Chapter 2, Article B, Section 4-2B-10 of the Village Code as set forth below (additions <u>underlined</u>; deletions <u>stricken</u>):

4-2B-10: CLASSIFICATION OF LICENSES:

* * *

C. Class C: Retail package sales. This license authorizes the retail sale of alcoholic liquors, in original package form, for consumption off the premises where sold. This license shall further authorize "sampling,", "tasting,", and "expanded

sampling" of alcoholic beverages strictly in accordance with the following definitions:

EXPANDED SAMPLING: Due to the fact that certain wines, liquors and craft beers are highly expensive and/or are available only in very limited quantities sporadically, rendering them difficult to market, larger packaged goods stores shall be permitted to engage in expanded sampling as follows:

- 1. Expanded sampling is available only to packaged liquor stores of not less than fifteen thousand (15,000) square feet in sales floor;
- 2. Sales by expanded sampling shall not exceed more than two percent (2%) by dollar value of all store sales;
- 3. Products dispensed under this classification may be sold for consumption on the premises, provided that not more than thirty two (32) ounces of any craft beer, four (4) ounces of any spirit or twelve (12) ounces of any wine may be sold to any customer in any one sales session;
- 4. Due to the unique nature of such sales, this license shall not be deemed a "pouring license" that authorizes or allows the store to install or operate any video gaming. In the unanticipated event the State Gaming Board determines that such a license does authorize video gaming, this license shall become null and void.

SAMPLING: A product sample, offered in connection with a sales promotion, consisting of no more than the following amounts: distilled spirits one-fourth $\binom{1}{4}$ ounce, wine one (1) ounce, beer two (2) ounces. Only products registered with the State Liquor Commission may be sampled.

TASTING: A supervised presentation of alcoholic products to the public for the purpose of disseminating product information and education, with consumption of alcoholic products being an incidental part thereof. Only products registered with the State Liquor Control Commission may be tasted in the following amounts: distilled spirits one-fourth ($^{1}/_{4}$) ounce, wine one (1) ounce, beer two (2) ounces. Notice of tasting may be advertised. Tasting must be supervised by the licensee and/or an authorized representative of the licensee.

SECTION 2: The Corporate Authorities hereby approve the amendment of Title 4, Chapter 2, Article B, Section 4-2B-10 of the Village Code.

<u>SECTION 3</u>: All ordinances, resolutions and orders or parts of ordinances, resolutions and orders in conflict with this Ordinance are repealed to the extent of such conflict.

 $\underline{\sf SECTION}$ 4: The Village Clerk shall cause this Ordinance to be published in pamphlet form.

 $\underline{SECTION\ 5}{:}\ This\ Ordinance\ shall\ be\ in\ full\ force\ and\ effect\ ten\ (10)\ days\ after\ passage\ and\ publication\ as\ provided\ by\ law.$
