#### I. CALL TO ORDER

Mayor Hanson called the September 25, 2019 Special Meeting of the Board of Trustees to order at 10:03 pm in the Antioch Senior Center: 817 Holbek, Antioch, IL.

1. Consideration of a Resolution authorizing a façade grant for 914 Main Street – Director Garrigan reviewed the request for a façade grant heard earlier in the evening at the Committee of the Whole meeting from Las Vegas Restaurant.

Trustee Dominiak moved, seconded by Trustee Yost, to approve **Resolution No. 19-54** authorizing a façade grant for 914 Main street. Upon roll call, the vote was:

2. Consideration of a Resolution of the Board of Trustees of the Village of Antioch extending a Declaration of Disaster Emergency – Administrator Keim discussed the recent declaration of emergency signed by Mayor Hanson to mitigate the potential for flooding at the Pittman site located at the northeast corner of Main and Orchard Street. Recent heavy rains have increased the size of the sinkholes on the property, and the declaration allows staff to remove any debris on top of the site which should alleviate additional weight and decrease the probability of future failure.

Administrator Keim said he communicated with Mr. Pittman today, and Mr. Pittman asked that we also communicate with his legal team. Administrator Keim said he wants the ability to maintain creek flow as conditions arise and extend the emergency declaration indefinitely.

Trustee Yost moved, seconded by Trustee Dominiak, to approve **Resolution No. 19-55** extending a declaration of disaster emergency. Upon roll call, the vote was:

YES: 4: Macek, Yost, Dominiak and Johnson.

NO: 0.

ABSENT: 2: Pierce and Poulos.
