#### SUBJECT:

An Ordinance Adding One Class "E" Liquor License for Great Lakes Antique Boutique

#### SUMMARY AND BACKGROUND OF SUBJECT MATTER:

At the July 26, 2017 Committee of the Whole Meeting, the Village Board considered a request from Trent and Lauri Tobais to offer wine and beer tastings with a full service Bar & Tavern license. The petitioners stated their main intent to offer wine tastings at their 10,000 square foot retail store.

The Committee of the Whole expressed concerns with adding more gaming to the Village, and provided an option to Mr. & Mrs. Tobias to request a retail package with an expanded sampling license that would not be a permitted pouring license and not qualify for video gaming machines. At the conclusion of the discussion at that meeting, the petitioner was provided with two options:

- 1. Request a vote on the original petition as it has been submitted
- 2. Amend the original request to offer package sales with expanded sampling.

The petitioner has requested that the board vote on his original request for a Class "E" Bar & Tavern Liquor License. An ordinance has been prepared at the request of the petitioner for the board's consideration.

### ORDINANCE 17-09-xx

## AN ORDINANCE ADDING ONE CLASS E LIQUOR LICENSE, FOR GREAT LAKES ANTIQUE BOUTIQUE

**WHEREAS,** the Village Board has been petitioned by Trent & Lauri Tobias, the owners of Great Lakes Antique Boutique, a property located at 1615 Main Street (formerly 41055 N. Route 83), and in particular, the petition seeks an additional Class E liquor license which will allow them to conduct the retail sale of alcoholic liquors for consumption on the premises where sold as well as other retail sale of packaged liquor in its original containers for consumption off premises, and

**WHEREAS,** the Village Board has considered the petition and has determined that the proposal is appropriate for the suggested location and type of business, and that the petitioner is an appropriate designated licensee eligible to receive a liquor license, and

**WHEREAS,** the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, particularly where the offerings of the proposed business are unique and aimed at a target market that will likely draw people into town,

**NOW THEREFORE, BE IT ORDAINED** by the Village of Antioch, Lake County, Illinois, as follows:

**SECTION ONE:** The Village Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses to increase the number of Class E licenses by 1, effective at such time as Great Lakes Antique Boutique has qualified for a Village of Antioch Liquor License providing necessary documentation required by the administrative staff.

**SECTION TWO:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
