<u>SUBJECT</u>: Consideration of a Resolution authorizing the Village Administrator to execute a water tower lease agreement with Verizon Wireless

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

Staff has been in discussions with representatives from Verizon Wireless to lease space on the Heron Harbor water tower. At the COW meeting in January, this item was discussed. Equipment for cellular communication is proposed to be placed on the top of the tower along with cabling to a ground containment with additional equipment. The rent has been negotiated to be \$2000 per month in five year increments with 2% escalation in each year.

Verizon Wireless will be allowed by agreement for the installation, maintenance and operation of radio communications equipment at the Heron Harbor Water Tower.

\$24,000 annually
