SUBJECT: Approval of an Ordinance Amending Section 4-14-10(A) of the municipal code of Antioch updating the chart of tobacco licenses.

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

In December, 2015 the Village Board approved Ordinance No. 15-12-23 regulating and licensing of tobacco dealers. The number of licenses when the ordinance was approved, was yet to be determined upon completion and approval of license applications. Since that time, the number of tobacco licenses have been found as follows:

Class	Number
A	12
B	3
C	11

The attached ordinance updates the chart of licenses to what have been issued and is currently in effect.

ORDINANCE 18-02-xx

**AN ORDINANCE AMENDING §4-14-10(A)
OF THE MUNICIPAL CODE OF ANTIOCH
UPDATING THE CHART OF TOBACCO LICENSES**

WHEREAS, the corporate authorities previously adopted Title 4, Chapter 14 which established a licensing requirement for tobacco sales, and

WHEREAS, at the time Chapter 14 was adopted, there was no census of existing tobacco sellers, and as such, the enabling ordinance included the following section:

***SECTION THREE: Grandfathered Licenses.** As of the date of adoption of this licensing regulation, and recognizing the fact that a currently unknown number of existing retail establishments currently sell tobacco and e-cigarette products, the Clerk is directed to issue temporary licenses to all existing retail sellers of tobacco and e-cigarettes without regard to the numbers set forth in the chart in section 4-14-10 hereinabove, and to report to the Village Board on a timely basis of the total number of licenses issued with suggestions as to the amendment of the said chart of licenses.*

WHEREAS, the Village Clerk has been issuing licenses in conformity with the provisions of this Chapter, and at the present time reports to the corporate authorities that there are a total of 12 Class A licenses, 3 Class B licenses and 11 Class C licenses which have been issued and are currently in effect; and

WHEREAS, the Village Board finds that it is appropriate to amend the blank chart of licenses set forth in Section 4-14-10(A) to reflect the correct, current number of licenses in effect;

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: Section 4-14-10(A) of the Antioch Municipal Code is hereby amended and shall hereafter read as follows:

Class	Number
A	12
B	3
C	11

SECTION TWO: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
