RE: Antioch's Taste of Summer Festival 2019

The Antioch Chamber respectfully asks the Village Board permission to modify two items for Antioch's Taste of Summer 2019 and future years:

1. The Chamber would like to move the Taste one week earlier so we no longer compete with Country Thunder each year; and
2. The Chamber needs to host a few larger rides geared to adults and teenagers as part of the Taste to help assist with the financial backlash that rain and inclement weather brings. This would provide a more family-friendly carnival instead of the kiddie carnival we currently have. We would have rides for all ages available. In doing so, we would additionally place a few rides on the south side of the bandshell in the public lot.

The traffic flow would still be open from Ida to the back of the buildings on the east side of Main Street, with parking open on the south end of the public lot and in the Centegra parking lot.
