**ORIGINATING DEPARTMENT:** Community Development

**SUBJECT:** Consideration of a Resolution to approve a Façade Grant in the amount of \$1,127.50 for a fabric awning for the property commonly known as 913 Main Street.

### SUMMARY AND BACKGROUND OF SUBJECT MATTER:

The applicant is requesting a façade grant for an "awning" for his existing business which is located at 913 Main Street. Pursuant to the Village's Façade Grant program. The Villages Façade program permits the Village to provide a grant of up to 50% of the costs of a façade improvement. The applicant is proposing to install a "black" cloth awning for the sum of \$2,255.00 and the Village's reimbursement share of this awning would be \$1,127.50.

The Village Board recently approved a new awning for "Something Sweet" and has revised its policy to allow applicants to apply for awnings only as part of the Façade Program.
