<u>SUBJECT</u>: Consideration of a Resolution Authorizing the Village Administrator to execute an agreement with Premier Paving of Northern Illinois, Inc. to complete asphalt patching.

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

Two locations were included in an invitation to bid. The first location is on Anita Avenue where an emergency storm sewer replacement was performed by Public Works. A large area of pavement is needed to properly complete this project. The second location is a portion of Grimm Road from IL Route 83 east to the railroad tracks. Due to the poor condition of this section, new business and anticipated vehicle traffic it was included in the bid. With temperatures dropping, the size of the two areas and small window to complete the paving, staff felt it was best to bid these locations.

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO EXECUTE A CONTRACT WITH PREMIER PAVING OF NORTHERN ILLINOIS, INC. TO COMPLETE ASPHALT PATCHING IN THE AMOUNT OF \$32,884

WHEREAS, the Village of Antioch, Lake County, Illinois (the "Village") is a duly organized and existing municipality created under the provisions of the laws of the State of Illinois, and

WHEREAS, the Village has two locations in need of asphalt pavement repairs; location 1 being the area of Anita Avenue where storm sewer was replaced and location 2 on Grimm Road from IL Route 83 east to the railroad tracks; and

WHEREAS, the asphalt patching was put out to bid, and bids were publicly opened on November 7, 2018 at 10:30am; and

WHEREAS, the Village received four bids including Rabine Paving, Chicagoland Paving, Peter Baker & Son Company and Premier Paving of Northern Illinois, Inc. coming in with the lowest bid of \$5,496.00 for Location 1 and \$27,388.00 for Location 2; and

WHEREAS, due to the size, dropping temperatures and poor condition of the effected areas it is recommended to repair prior to the asphalt plants closing;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE MAYOR AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF ANTIOCH, LAKE COUNTY, ILLINOIS, to authorize the Village Administrator to execute a contract with Premier Paving of Northern Illinois, Inc. in the amount of \$32,884.00 with \$27,388.00 coming out of TIF funds
