<u>SUBJECT</u>: Consideration of an Ordinance deleting one Class "B" Liquor License together with Ancillary Class "B-1" and "B-2" Licenses and Creating one Class "A" License, along with "A-1" Ancillary Licenses for Lucky Bernies

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

At the August 10, 2016 Committee of the Whole Meeting, the Village Board heard a request from the owner of Lucky Bernie's for a Class "B", "B-1" and packaged liquor license. At that time, the applicant indicated that he would like to operate a deli, and provide for the sale of beer and wine with the option to sell packaged wine as well.

Upon completion of their business in September, 2018, Lucky Bernie's was issued a Class "B", "B-1" and "B-2" liquor license. In 2019 it was discovered that they were selling hard alcohol as well, and they were advised they were only licensed to sell beer and wine. In response, the owners presented a letter requesting a Class "A" license which was sent to the liquor commissioner. The request was considered at the June 10, 2019 and July 8, 2019 Village Board meetings, where the Village Board requested the applicant come back in one year provided there were no violations.

At the September 23, 2020 Committee of the Whole meeting, the applicant presented their request for a full restaurant liquor license. The board agreed to place this item on the next Village Board agenda for consideration.

ORDINANCE 20-xx-xx

AN ORDINANCE DELETING ONE CLASS B LIQUOR LICENSE, TOGETHER WITH ANCILLARY CLASS B-1 AND B-2 LICENSES AND CREATING ONE CLASS A LICENSE ALONG WITH A-1 ANCILLARY LICENSE FOR LUCKY BERNIE'S

WHEREAS, the Village Board previously granted a Class B liquor license along with ancillary B-1 and B-2 licenses to Lucky Bernie's, and

WHEREAS, the establishment has been in operation for a period of approximately 1-1/2 years and has determined that its business plan and model needed to offer a wider range of drinks to attract the type and number of patrons required to reasonably sustain the business, particularly since the economic problems caused by the recent COVID-19 pandemic, and

WHEREAS, the establishment's current group of licenses allows basic restaurant indoor service of beer and wine (B), patio seating (B-1) and package sales of wines (B-2), and

WHEREAS, the Village Board has considered the petition and has determined that the proposal is appropriate for the suggested location and type of business, and that the petitioner has made a substantial investment in its business, and

WHEREAS, the Village Board finds that providing an analogous license which would allow the package sales of wine only by Class A licensees is an inappropriate step that further blurs the distinction between retail stores and restaurants, and for that reason is not considering creating such a license for this business, and

WHEREAS, the Village Board wishes to expand business opportunities wherever possible, for the overall benefit of the citizens and taxpayers of this Village, particularly where the offerings of the proposed business are unique and aimed at a target market that will likely draw people into town,

NOW THEREFORE, BE IT ORDAINED by the Village of Antioch, Lake County, Illinois, as follows:

SECTION ONE: The Village Clerk, acting as the Secretary of the Local Liquor Commissioner is directed to revise the chart of allowed liquor licenses to decrease the number of Class B licenses by 1, along with decreasing the number of Class B-1 and B-2 licenses by one each, effective immediately.

SECTION TWO: The Clerk shall further revise the chart to increase the number of Class A and A-1 liquor licenses by one each, and the Local Liquor Commissioner is authorized to cause the resulting created licenses to immediately issue to Lucky Bernie's.

SECTION THREE: The Clerk shall charge to condition of the issuance of the Class A license charged for a Class B license and the Class A license.	e to compensate for the difference between the fee
