SUBJECT: Consideration of a Resolution Authorizing the Village Administrator to execute a contract with Advance Fence, Inc. to replace the fence on Village Owned property at Mary's Park in the NeuHaven Subdivision.

## SUMMARY AND BACKGROUND OF SUBJECT MATTER:

With the importance of properly maintaining Village infrastructure and structures, it has come to our attention that the fence located at Mary's Park located in the NeuHaven Subdivision needs attention. There are 7 homes on Devon Drive and 7 on Bradford Lane with rear yards that abut the fence. Over the years the fence has lifted and shifted causing sections to break, fall out and ultimately affecting the function of the gates.

Quotes were requested from five companies with two responses. The quotes received were Advance Fence, Inc. at \$74,952.00 (5-year workmanship & material guarantee) and Superior Fence Company at \$80,560.00 (3-year workmanship & material guarantee). The proposal for Superior Fence Company has expired and we are awaiting a revised quote.
