SUBJECT: Consideration of a Resolution Authorizing the Village Administrator to Execute an amended contract with Mad Bomber Fireworks Productions to provide the annual fireworks show for the Village of Antioch for Period of One Year in 2021 in the amount of \$30,000.

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

In 2020 the Village of Antioch was given an extension on the contract with Mad Bomber Fireworks Production. Due to the pandemic no services were completed in 2020.

The 2020 proposal was for \$20,900 for a 25-minute show. The 2021 show will be 30 minutes in length with bigger fireworks. The Antioch Township Supervisor, Tom Shaughnessy, via email has agreed to split the cost of the contract with the Village of Antioch.

FINANCIAL IMPACT: \$30,000 Annually

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO EXECUTE AN AMENDED CONTRACT WITH MAD BOMBER FIREWORKS PRODUCTIONS TO PROVIDE THE ANNUAL FIREWORKS SHOW FOR THE VILLAGE OF ANTIOCH FOR A PERIOD OF ONE YEAR IN 2021 IN THE AMOUNT OF \$30,000

WHEREAS, the Village of Antioch, Lake County, Illinois (the "Village") is a duly organized and existing municipality created under the provisions of the laws of the State of Illinois; and

WHEREAS, in March, 2020 the Village Board approved a one-year contract with Mad Bomber Fireworks to provide the annual fireworks show for the Village of Antioch Independence Day Celebration in the amount of \$20,900 for a 25-minutes show; and

WHEREAS, due to the Coronavirus, there was no service rendered for the existing contract and Mad Bomber offered a one-year extension; and

WHEREAS, in February, 2021 Mad Bomber submitted an amended proposal for a 30-minute show in the amount of \$30,000. The cost for an additional 5 minutes of display from the previous contract total for 2020 is \$9,100; and

WHEREAS, staff is recommending that you award the bid to Mad Bomber Fireworks Productions in the amount of \$30,000 for the 2021 Fireworks Program;

NOW, THEREFORE, BE IT RESOLVED, The Mayor and Village Board to Authorizing the Village Administrator to Execute an amended Contract with Mad Bomber Fireworks Productions to Provide the Annual Fireworks Show for the Village of Antioch for period of One Year in 2021 for the Amount of \$30,000.
