SUBJECT: Approval of a Resolution approving the 2022 Village Board of Trustees meeting schedule.

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

Pursuant to 5 ILCS 120/2.02, each year municipalities must prepare a schedule of all regular meetings for the coming year containing the regular dates, times and places and post notice of those schedules. Village Board meetings and the Committee of the Whole meetings are scheduled for the second and fourth Wednesday of each month at 6:30 pm, unless otherwise noted. Meetings are held at the Village Hall Board Room, 874 Main Street. As with last year, the following guidelines remain.

1. Meetings will be scheduled on holiday dates when the Village offices are open for business (i.e. Martin Luther King Day and Presidents' Day)
2. Meetings will not be scheduled or rescheduled for legal holidays when the Village offices are closed for business.

Due to the Thanksgiving Holiday, the second November meeting has been rescheduled to November 30. There will be no meeting scheduled for the second Wednesday in December.

Planning and Zoning Board meeting have been changed from the second Thursday of each month to the first Wednesday of each month at 7pm. Planning and Zoning Board members have been notified of the change.

For the Board's information, other commission meeting schedules are also included in the attached list. These meeting schedules have been, or will be, approved by each individual commission and are subject to change. The annual schedules are sent to press and posted on the Village's website and at Village Hall.
