SUBJECT: Consideration of a Resolution Authorizing the purchase of 55 parkway trees in the amount of \$16,225.00 from McKay Nursery Company

AND

Consideration of a Resolution Authorizing payment to Arthur Weiler, Inc. for tree planting services in the amount of \$8,525.00

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

The Public Works department has removed parkway trees throughout the Village that have been infected by the Emerald Ash Borer. The removal of these parkway trees has sparked interest from various Homeowners Associations that would like to participate in a program for the replacement of trees. The proposed resolution authorizes the Village Administrator to purchase 55 trees for a Spring planting and employ Arthur Weiler to plant the trees. The locations of the trees will be determined by the public works department and are based on the current species and HOA participation.

FINANCIAL IMPACT: \$24,750.00 (Minus contributions of \$11,700.00)
