SUBJECT: Approval of a Resolution Approving the 2022 Tag Day Schedule

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

On October 3, 2011 the Village Board passed Resolution 11-87 Revising Existing Policies for Street Sales and "Tag Day" Events. In that policy, it states that the specific weekends which are available for those events shall be designated annually by the Village Board in the first quarter of the calendar year. Regulations limit tag days to 10 weekends between April and November, and there shall be no more than 2 licenses per month. It further states that licenses shall be granted on weekends only, and cannot exceed 2 days.

The 2022 Tag Day Fundraising schedule has been reviewed by staff and has been approved by staff as follows:
