**SUBJECT:** CONSIDERATION AND APPROVAL OF A RESOLUTION FOR A SPECIAL EVENT LIQUOR LICENSE FOR THE VILLAGE OF ANTIOCH FOR IT'S THURSDAY SUMMER KICK-OFF CONCERT WITH RODNEY ATKINS ON JUNE 8, 2023, 93 XRT DECADES WEEKEND JULY 7-9, 2023 AND THE MIKE & JOE SERIES FINALE ON AUGUST 10, 2023.

## **SUMMARY AND BACKGROUND OF SUBJECT MATTER:**

THE VILLAGE OF ANTIOCH IS REQUESTING A CLASS "G" SPECIAL EVENT LIQUOR LICENSE PURSUANT TO VILLAGE CODE 4-2B-10 FOR THE VILLAGE OF ANTIOCH'S IT'S THURSDAY SUMMER KICK-OFF CONCERT WITH RODNEY ATKINS ON JUNE 8, 2023, THE 93 XRT DECADES WEEKEND, JULY 7, 8, 9, 2023, AND AUGUST 10, 2023, IT'S THURSDAY PERFORMANCE BY MIKE AND JOE AT THE ANTIOCH BANDSHELL.

THESE EVENTS ARE SCHEDULED TO BE HELD ON JUNE 8, 2023, JULY 7,8,& 9, 2023, AND AUGUST 10, 2023, FROM 5:00 PM-10:00 PM AT 900 SKIDMORE.

IN AN EFFORT TO RECUPERATE SOME OF THE INCREASED COSTS ASSOCIATED WITH HOSTING CONCERTS, THE VILLAGE OF ANTIOCH HAS SELECTED SEVERAL CONCERTS THIS SUMMER THAT WILL HAVE A HIGHER ANTICIPATED ATTENDANCE THAN OTHERS, TO MANAGE ALCOHOL SALES DIRECTLY. VILLAGE STAFF CONSERVATIVELY ESTIMATES PROFITS FOR THE SUMMER FROM ALCOHOL SALES AT THE BANDSHELL, TO BE APPROXIMATELY \$12,500.

**RESOLUTION AUTHORIZING A SPECIAL EVENT LIQUOR LICENSE FOR THE VILLAGE OF ANTIOCH FOR SELECTED SUMMER CONCERTS AT THE WILLIAM E. BROOK ENTERTAINMENT COMPLEX (ANTIOCH BANDSHELL) JUNE 8, 2023, JULY 7, 2023, JULY 8, 2023, JULY 9, 2023, AND AUGUST 10, 2023, WAIVING ALL FEES.**

WHEREAS, the Village of Antioch (“Village”) is a municipality located in Lake County, Illinois; and

WHEREAS, the Village of Antioch is requesting a Special Event Liquor License for selected summer concerts at the William E. Brook Entertainment Complex; and

WHEREAS, the selected It’s Thursday summer concerts are scheduled to be held on June 8, 2023, July 7-9, 2023, and August 10, 2023 from 5:00 pm to 10:00 pm at 900 Skidmore Drive, Antioch, IL 60002.
