### **CITIZENS WISHING TO ADDRESS THE BOARD**

James Freedman, Rembrandt Drive resident, distributed a copy of his prepared statement to the Village Board and then read it aloud. He said that he is sorry that he has to continue his quest for an answer to a question that he thought could be answered simply and in a short period of time. Mr. Freedman said that he is frustrated with this administrations lack of follow-through and the inability to inform the citizens of Antioch with a clear answer. Mr. Freedman referred to the letter from Administrator Haley which was a response to his question that he asked the Village Board on March 16 and said it is not an answer to his question that he has been asking regarding the utility tax. He said that he is confused as to why the Board cannot answer how much was collected during the eight months after the utility tax ended. He said the accounting department should have been able to answer this question in a very short period of time. He said that he believed that he expressed himself clearly, however he is in a quandary to Mr. Haley's explanation. He said Mr. Haley's response does explain the disposition of the remaining utility tax funds, but it does not answer the question that he continually asks. Mr. Freedman said that it's the Board's responsibility to approve expenditures over \$10,000 and if this is the case, then all should have known the amounts received and how, where and when it was distributed. Mr. Freedman asked if the tax money has been spent, as stated in Mr. Haley's letter, why the Mayor and Board of Trustees didn't answer his question when it was asked.

Officer Nowotarski responded to the home of a 79 year old female possibly having a heart attack. While speaking with the victim, she collapsed and Officer Nowotarski began life saving measures using the defibrillator and performing CPR and was able to revive the victim and she was transported to the hospital via ambulance. Officer Nowotarski's quick and efficient response to this call, while remaining calm in the face of potential tragedy should be commended. His heroic actions saved the life of this victim.
