# 5. Consideration of an Ordinance Amending Section 4-2B-10-B of the Municipal Code of Antioch Modifying the Class "B" license Regulations by Allowing Package Sales of Wines – Ordinance No. 16-09-23

Mayor Hanson reminded the board that over the summer a resolution approval by The Village Board relating to video gaming was sent to Springfield. Two Senators are working on passing a bill that would allow us more control over video gaming, and possibly the board would want to hold off on making a decision. Mayor Hanson also added that the Village receives numerous video gaming requests on a daily basis, and his concern is if other similar requests are received would we have to allow them.

Trustee Dominiak wanted to go on record that she is very disappointed that we are at this point with this petitioner and very sorry that he withdrew. She added that she spoke with the realtor and the petitioner is adamant he is not going to move forward on this project. She would have welcomed an opportunity to discuss this resolution as it was written.

Trustee Poulos recommended the board discuss what we want to do and what can be done to assure this doesn't happen again. He added that he doesn't feel the Village should give away land, just have guidelines in place that would help bring in businesses. If the petitioner didn't withdraw and the changes proposed were complete, it would have improved the view coming into town. He would like the board to consider discussing this at a future Committee of the Whole Meeting.

Attorney Long suggested a protocol on what we are looking for from a developer. Trustee Jozwiak agrees with Trustee Poulos that we need to guidelines in place to help the Village work with developers. Trustee Macek suggested we speed up the current process so developers aren't waiting months for a solution. Trustee Pierce feels a serious developer needs to have a completed project in hand which could speed up the process.
