8. Consideration of a Resolution Granting a Conditional License to the owners of 945 Main Street allowing the Conditional use of Village-Owned Property and Granting a Business Development Incentive Package – Resolution No. 18-40

Trustee Dominiak moved, to approve a resolution granting a Conditional License to the owners of 945 Main Street allowing the Conditional use of Village-Owned Property and Granting a Business Development Incentive Package in the amount of \$200,000, seconded by Trustee Poulos.

Trustee Johnson and Trustee Macek recused themselves from this discussion.

Resident and Antioch Planning and Zoning Board Member, Bob McCarty, explained that the incentive package is being used as intended and will benefit the downtown.

Township Resident, Tony Hileman, does not agree with the incentive package.

Resident and Timeless Treasures owner, Sam Griffin, supports the incentive package. He agrees with the village on keeping downtown alive.

HairScapes Salon owner, Carrie Washburn, is excited about the proposed establishment but is concerned about parking and garbage dumpster. They are a small business that relies on close parking for their elderly clients and between the customers and employees for the strip mall the parking lot is regularly full.

Resident, Mary Pedersen, is excited about using the economic development to enhance Downtown Antioch and supports the board.

Mexican Paradise owner, Brian Bezak, stated the proposed restaurant incentive program would be good for Antioch, he is just concerned other structures could benefit from the money allotted for the incentive program.

Tin Cat Treasures owner, Deborah Piofrowski, has only been in business one year and is struggling. She feels the restaurant would benefit all the stores downtown and is in favor of the incentive program.

Inspired Home owner, Christine Talaber, explained her business is also struggling and is in support of bringing business to the downtown.

Antioch Theatre owner, Tim Downey, explained he feels the parking is the biggest issue and replacing parking would help the downtown businesses.

Resident, Leslie Strohman, is in favor of the restaurant. She is hopefully this will bring other businesses as well as consumers into Antioch.

Selina's Secrets owner, Tami Spiller, explained that she is also in favor of the restaurant. Her only concern is parking as well as the two-hour limit on Main Street.

Liquid Smoke owner, Max Davenport, explained his business has struggled as well and feels this restaurant will benefit everyone. He also feels this will help fill the vacant locations around town.

Resident, Matt Serzinski, is against the incentive for Rivalry Ale. He fills a business should not rely on tax payer dollars.

Trustee Jozwiak is concerned about the businesses off Park Ave that will be affected by the parking issues. Trustee Jozwiak does not support the \$200,000 incentive or the uses of the municipal lot. He agrees with other business owner that a business should make it on their own and not rely on tax payer money.

Trustee Pierce explained several years ago as a board we made a commitment to do what it takes to make this town grow. We have purchased property for a TIF district, we have given millions in incentive programs to build, we have given land in order to grown Antioch. If someone comes before the board, we review their request on a case by case basis. If parking is our problem, then that means we are being successful because people are here, and we are making money, improving property values.

Trustee Poulos stated we are making an investment in this town just like we have with the Antioch Theatre, Lovin Oven and property we've purchased. The question is will be getting our money back, and yes, we will in tax revenue. He added that some of the parking off Park Ave is private property we would have to try and work with the owners on a solution.

Trustee Dominiak added that the Police Department is working on re-writing regulations to try and make them more business friendly.
